Report COVID-19 Cases

If you or someone involved in your project has tested positive for COVID-19, you must ensure the university is informed.

Ask the individual to fill out SDSU's reporting form. To ensure reporting is completed and Student Health Services is aware, the research leader must also submit this form. If the individual is an SDSU Research Foundation employee, they must also inform their HR business partner and email sdsurfriskmanagement@sdsu.edu. The infected person must immediately stop participating in research.

County Corner

Vaccines Arrive!

The first deliveries of 28,000 San Diego vaccines are being made to the County, UCSD Health and Rady Children's Hospital. Each organization will determine how to prioritize and administer the vaccines to its employees.

Residents and employees of skilled nursing facilities have a high priority to receive the vaccine, but distribution to these recipients is being handled separately by the state. Those doses will go to local CVS and Walgreens pharmacies which will administer the vaccine to skilled nursing facility residents and staff.

San Diego County COVID-19 Stats – 12-15-2020

- 1,863 new cases were reported to the County on Dec 14. The region's total is now 111,441.
- 5,212 or 4.7% of all cases have required hospitalization.
- 1,118 or 1.0% of all cases and 21.5% of hospitalized cases had to be admitted to an intensive care unit.
- The current ICU capacity for the Southern California region is now 1.7% and will be updated by the state daily.
- The 14-day rolling average percentage of positive cases is 8.1%. Target is less than 8.0%.
- Thirty-two new COVID-19 deaths were reported to the County on Dec. 14. The region's total is now 1,194.
