## **Scope and Audience**

SDSU Principal Investigators conducting human subjects' research.

## **Additional Authority**

45 CFR 46, 21 CFR 50, 56

# 1. Policy Purpose

To ensure that informed consent is obtained and/or interpreted in a language that is understandable by potential research participants.

# 2. Policy Statement

Translation and/or interpretation of informed consent documents that reflect the study population that the PI wishes to recruit for participation is required at all review levels. If the PI does not employ a certified translator and/or interpreter, they must provide evidence in the form of a statement about their level of proficiency in the language and their experience in translating and/or interpreting documents from English into the foreign

language relevant to a study population. They must attest that they are the individual who translated and/or interpreted the informed consent document(s), and that they have the expertise to do so. At the time of IRB submission all consents and relevant study documents must be submitted in English. Translations of IRB-approved documents must be submitted as an amendment.

#### 3. **Definitions**

IRB Policy Number: 23-0001

**Proficient** [regarding translation and/or interpretation]: The ability to translate and/or documents well due to education, training, experience, and practice. An advanced knowledge of the language the document is to be translated to and/or interpreted in as was as an advanced knowledge of the language to be translated and/or from. Proficiency requires an in-depth cultural knowledge including understanding cultural idioms, and the ability to communicate effectively in writing as demonstrated by knowledge of grammar rules, punctuation rules which may differ in foreign languages.

**Certified translator**: An individual who has passed a certification exam to verify their translation skills.

**Certified translation:** One where a translator or another reviewer provides a [written]statement, in addition to the translated document The statement which includes:

- A statement of the translator's qualifications.
- A statement affirming the completeness and accuracy of the document.
- Identification of the translated document and language.
- The translator's name, signature, and date.

**Certified Interpreter**: An individual who has been certified as competent by a professional organization or governmental entity through testing based on consistent criteria.

**Qualified Interpreter**: An individual who has been assessed for professional skills, demonstrates a high level of proficiency in at least two languages and has the appropriate training and/or experience.

**IRB Review levels**: There are three levels of review, exempt, expedited, full board.

- **Exempt**: The human subjects research proposal meets criteria to be reviewed under 45 CFR 46.104
- **Expedited**: The human subjects research proposal meets the criteria to be reviewed under 45 CFR 46.110.
- **Full Board**: The human subjects research proposal does not meet the criteria to be reviewed at 45 CFR 46.104 or 45 CFR 46.110.
